# TURKEY TRAPS

A trap-gimmick rally presented by  
Santa Monica Sports Car Club & Cal Club Region of SCCA  
(an SCCA GTA Regional RoadRally)

- Rally Concept:** On a traditional course rally you must stay on time while avoiding traps. On a trap-gimmick rally you do not have to stay on time, so you have time to re-read the rules, and to go back to re-check a sign or an intersection, and to actually THINK about what you're doing.
- Starting Location:** Pizza Hut – 10719 Sepulveda Blvd, Mission Hills  
(about ½ mile north of the regular SMSCC starting location)  
(near the intersection of Chatsworth Street & Sepulveda Blvd.)
- Times:** Registration opens at 11:30 AM; rally cars are expected to start the rally around 12:30 PM.  
Rally ends at a restaurant in the northwest San Fernando Valley  
(less than 10 miles from the start).
- Price:** \$30 if you pre-enter by October 28th; \$40 at the start.  
(We strongly advise you to pre-enter so that you can become familiar with the Rally Rules in advance.)
- Minors:** For a minor to participate, both parents must sign the SCCA Minor Waiver. Each parent's signature is only valid if the parent signs in the presence of the rally registrar, or the parent's signature is notarized. You can download the minor waiver from:
